So our Brad tries to hold Nick accountable and listen to the woman and respect her space and Tim and Angelina look at each other and nod that yes our Brad must be losing his mind because EVERYONE KNOWS in 2017 you only listen to other people's stories you are NOT ALLOWED to hold people accountable to sensibilities....that is just a faux pax, it is uncouth, it is not socially acceptable....it is not **MIND YOUR OWN BUSINESS**.

Well our Brad does not know how to mind his own business and he always defends women and he steps in where others wont.

The next day Angelina starts calling her family and Brad's family and telling them she is worried about Brad and that he is exhibiting forms of mania.

1. He is excited (about work, losing weight, being more of a dad, dreaming of a new business...you know all that bad stuff humans shouldn't be doing...they should be mediocre and average and not stand out)
2. He is argumentative (challenging Nick and trying to hold others accountable...again things humans should not do...under all conditions you should always mind your own business even when someone is suffering..you can however say "you are sorry" when you really aren't...)
3. He is sleeping less (as is customary when someone is excited about life and springs out of bed to attack the day)
4. He is talking about larger dreams (can you imagine that our Brad was talking about wanting to help other individuals and help play his part in "being the change he wished to see in the world"...Angelina thought "why couldn't Brad just be a good "mind your own business" middle class Long islander and just follow the script!!!")

Well Angelina's family takes the bait and Brad's family (*who was always a little jealous of him and sick and tired of him trying to live to higher ideals*) also takes the bait.

The day after Angelina had admitted to her infidelity and soaked the bed with crocodile tears....she quickly went into action turning Brad's family, his best friend, and her family against Brad. He was a sitting duck and didn't know it.

So what ensues is conversation after conversation with friends, acquaintances, and Brad's own family where Brad pleads for anyone to believe him. He details the story of how Angelina is lying and that she just told him that she was being unfaithful then she left with his son and told everyone he was going manic.

2017 was a bad year for our Brad...

- He had to fight for access for his son and only got to see him supervised
- His business fell apart because he was so shaken by the loss of his son and the lies spread about him
- He lost all of his "friends" and acquaintances
- Most notably he lost confidence in himself and by December 2017 with his life in ruins he started to believe the lies and that he might indeed not be well mentally

Brad was able to do complimentary work for his in-laws and take care of people with his money and resources for his business. In 2023 he even started to discuss helping finance Angelina and her friend's dreams of opening a Crossfit gym (he knew they didn't have any business savvy...they spoke more about spreading community than turning a profit but he felt their heart was in the right place).

So Brad gently told the three women (all of them mothers to young children) that they were over their skis (meaning they would crash and burn and wipe out if they tried and they had no money) so Brad helped recruit a strapping young dad that could run a gym full time and Brad committed a large portion of his own savings to make Angelina happy.

Well in February 2024 the unthinkable happened to Brad....although Brad's grandfather Anthony had always issued a warning... (for Anthony Hopkins...Brad's grandfather is a legend and how many better legendary actors are there than the great Anthony Hopkins)

"FOOL ME ONCE SHAME ON YOU....FOOL ME TWICE SHAME ON ME."

Well Angelina started to question Brad's sanity again. Remember:

1. Brad is now helping to start up a new gym for Angelina
2. Brad is excited about the new enterprise
3. Angelina is seeing Brad in the business world where he is aggressive

Angelina again starts telling her family and Brad's family about her concerns and they start asking Brad if "he is all right"....

THEY START ASKING HIM TO PROVE A NEGATIVE

This time Brad is more prepared for what is about to happen and he remains calm. Still Angelina's attacks persist. And Brad's family specifically his sister starts saying "We are worried about your...we just want the best for you"

Somehow using her charm Angelina gets a mutual friend and coworker Kevin (named after Kevin James...dumpy Dad like figure except Kevin is not as funny as Kevin James). To also turn on Brad and worry about his mental stability. Brad decides to tell Kevin and Clint to take a break and let him sort things out with Angelina and the business.

Angelina threatens to call the cops if Brad doesn't either leave the house or take anti-psychotic medications and Brad calmly complies and leaves the house with \$700,000 in cash from his home safe and some clothes.

Brad remains calm and doesn't get argumentative as he has learned from 2017 (never get argumentative with the enemy) Well a couple of days later Angelina gets Nassau County Police to do a wellness check on Brad forcing Brad to have to:

PROVE A NEGATIVE

Brad stays calm and shows the officers text messages he had from Angelina admitting her recent infidelity and the officers apologize and admit that this is common place in 2024 and leave.

Outside Angelina, Clint and Angelina's mother Leah (Leah Remini is just an annoying actress that has an annoying voice that only worked with Kevin James and is otherwise an average looking woman with little to no acting ability...that being said she gets clicks...so book her!!)

Well Angelina, Clint, and Leah go to work on the officers and get them to come back in and do another wellness check and then they again ask Brad to:

Brad calmly talks to them and they again leave. Angelina (using her credential as a psychiatric nurse practitioner) with her parents continue to insist and get another medical police to show up and question Brad...and again get him to:

The new medical officer wanting to get some lunch and move on with his day and seeing that Angelina and her cohorts mean business decides to trick Brad and convince him that he will just get him to the hospital and get him “in and out in an hour or so” and to “trust him”. Brad asks if he has a choice...the officer says “not really” so Brad is taken to the hospital.

At the hospital Brad is stripped of all of his clothes and made to wear a hospital gown and wait from 3pm to 8am the next day in the emergency room as nothing more than a hospital prisoner being held against his will. Still Brad remains calm.

Now behind the scenes the villain of our story Angelina is working her contacts with a psychiatric doctor that has the feels for Angelina. The hospital waits to interview Brad for 17 hours when he has had no sleep sitting in the middle of the emergency room with little food and no updates.

In the morning Brad finally meets with Dr. Jeff...“Wizard of Oz”, (it was a woman psychiatrist but we will make it a man and call him Dr. Jeff for Jeff Goldblum because he would make a good bumbling know it all insecure psychiatrist like he did in WICKED...one of Brad’s favorite movies...because of Ariana Grande...Cynthis Erevo...amazing plot lines and sensational music and the ironic twist on Wizard of Oz...)

Now before Dr. Jeff met with Brad of course Dr. Jeff had to meet with Angelina who had deep connections in the hospital and of course Dr. Jeff didn’t want to be impartial he had to hear Angelina’s side first in order to make a VERY “scientific” evaluation into Brad’s mental health.

So now the Wizard meets our Brad and the conversation lasts for about 3 minutes. And in that 3 minutes Dr. Jeff (AKA the Wizard) makes the proclamation that our Brad is indeed manic and sentences Brad for an indefinite stay in the beautiful psychiatric ward in the wizards castle on the south shore of Long Island.

Brad imprisonment in the castle lasts 10 days and frankly those 10 days is a movie or a book onto itself lets just say its interesting and our Brad spreads his wings and takes detailed notes about the inner workings of how we supposedly “care” for mentally ill people in the year 2024.

2. 3. Angelina gets the old manager to open the safe (he is the only other person besides Brad with the combination) and promptly steals \$120,000 from the safe.

Brad meanwhile is in the hospital catching wind of all of this and has to:

1. Do a social media post declaring he is in the hospital and his business is still open
2. Hire a lawyer for \$10,000 with cash money thankfully his good friend Fabio (yes the model Fabio...Brad always called his friend the Brazilian Fabio). *Brad had trusted his friend Fabio with \$550,000 of the \$700,000 he had taken from the house when Angelina threatened him.*
3. Brad had Fabio give \$150,000 to Keith (his florist...I know it sounds far fetched but stick with me...he isn't Jewish but he is a real Mench!)
4.  - a.  - c. Fabio does the right thing and calls the police
 - d. Kevin is the only one arrested but because he is

 - iv. Because he is all three he is released WITHOUT ANY jail time and no criminal record!...listen membership has its privileges and Kevin had membership in a few privileged groups

Meanwhile our Brad is keeping his **“you know what together”**

3. Brad is now faced with the prospects of getting out and not having access to his children
4. Brad does have a phone and Joey Bag of Donuts and lot of nut cases to entertain him while he cannot use the phone
5. Brad actually likes the hospital food....

6. Brad is able to do push ups and flirt with a couple of the nurses
7. Brad is thinking this could make a pretty cool movie!

After about 5-6 days....

Brad is in the phone room making his business calls and arranging the purchase of a brand new Range Rover (*he wanted to treat himself for all this fiasco and give himself something to look forward to but of course later this was spun against him as reckless spending!*)

Suddenly Brad looks over and reads the fine print on a poster revealing how he can get out of the Wizards Castle!

Obviously the lawyer saw the truth that the system and gobbled up a sane man and was preventing him from running his business and life and was basically imprisoning him and utilizing health care money to do so!

What follow from here is Brad getting released from the psych ward and turning his attention to the Nassau County Family Court System in order to get access to his children...

1. Brad goes to Family Court 4 times in 3 months each time getting more access to his children
 - a. First time he is allowed phone calls
 - b. Then he is allowed one hour visits once a week supervised
 - c. Then he is allowed visits
 - d. Then the case ends and he is allowed shared custody with our villain Angelina
2. Brad represents himself pro se
3. Agelina's attorney...slightly above average looks...definitely girl next door vibes...charges Angelina \$20,000 for 4 court visits and her sage advice.

(Expensive if you ask me but it's a free country if you see what some of these Only Fans models make it would make Angelina's lawyer blush and jealous!)

4. Brad each time he goes to court reminds the judge
 - a. He has never been physically violent
 - b. He has never yelled at Angelina
 - c. He is a dedicated father being prevented from seeing his children based on an email that had no physical or mental harassment threat

Brad is able to rebuild his business yet again and pay Angelina over 10K a month from July 2024 to December 2024.

Poor Angelina was so traumatized by Brad not agreeing with her that she couldn't work much and she also had to make time for her new boyfriend who she met less than a month

after kicking out the love of her life Brad in March of 2024. In fact Angelina decided to proudly post a frame over their bed in Brad's old bedroom that says:

"The Day the Earth Stopped for Us"

April 6, 2024

That was the day that Angelina met the new love of her life. She had to dump Brad as she knew she couldn't control him, George (the ex co-worker she kept cheating on Brad with) was still married, and so now Angelina was onto Jim

(Jim Carrey...taller guy...funny face and star power and I know Jim Carrey could pull off an average step father role and be a beta male living in the house of an Alpha male -Brad-who pays for the mortgage and utilities and food while he becomes a glorified pool boy).

2. Brad rebuilt his businesses and planned to make his next move.
3. Brad downloaded his experiences with his Ghost writer and developed a mock “Bipolar playbook” that he proudly announced to his sister and Angelina to keep them relaxed.
4. Brad got back into the dating world and rebuilt his Moxy, got in better shape, and started eating healthier.

Fast Forward....May 2026 Memorial Day Weekend

- As Brad started to climb back up and get more enthusiastic about life this time it was his sister Jennifer that was the leader of the mob

(Jennifer Anniston – not as attractive as Jennifer Anniston and wrong color hair but just as uptight as you could imagine Jennifer Anniston to be and a whiny female dog and someone that prefers to have a beta male around)

- Jennifer started to conspire with Angelina and ask Brad if he was “ok” or basically

“TO PROVE A NEGATIVE”

Friday evening of that weekend Jennifer and Angelina (who at most times were bitter rivals and spit venom at each other via Brad but during times of war became strange “bedfellows”

So Brad sat at his dining room table with these two bitter rivals and remarked to Jennifer and Angelina how happy he was that these two people who talked so much smack about each other were getting along so nicely. *(Our Brad is always so willing to put people on their toes)*

The evidence provided is faulty evidence based mostly on text messages non-threatening in nature.
- Brad stays away from long Island and spends some time admiring the South and continuing the work with his non profit for homeless people and underprivileged people
- Family Court Calls Brad saying he is missing his court appearance but Brad reminds the court secretary that he was never served and never had the court date.

- Nassau County Police call saying they need Brad to come in and that he will be arrested for violating the order of protection because of a text message to his ex mother in law where he stated the name Angelina and how that is a violation of the order

(Brad explains the technical term of 3rd party contact to the detective but the detective decides to use the definition he came up with...again its 2026...you are allowed in school to come up with your own definition so why shouldn't the police be allowed to do so!!!)

- Brad drives to upstate NY and stays in Ithaca for the weekend and prepares to come back to NY to turn himself in. However one of this videos gives off his location and Ithaca police pull him from his hotel room at 5am and take him away in handcuffs without a call to an attorney or reading any rights.
- Brad is then brought to Nassau Country Sheriff's who meet Ithaca police halfway.
- Nassau Country Sheriff's then bring Brad to Family Court Jail and it is then they realize that Brad has never been served. So they quickly read Brad the order and slide the order of protection in his suitcase.
- Brad spends over 35 hours arrested between the following
 - Ithaca police
 - Nassau County Sheriff's
 - Nassau County 4th precinct
 - Nassau Country Mineola detainment/Corrections officers
- None of the law enforcement officers give Brad the opportunity to call anyone to let anyone know he is alive and any marching orders regarding the business.

Next 2 ½ Months

- Brad's name is sullied by the whispering campaign of Angelina and his sister Jennifer
- Jennifer (Brad's sister) changes the locks on Brad's house he had purchased with his money (\$150,000) and renovated (\$100,000) and upon returning from his trip to and getting arrested he found the locks changed and all of his children's possessions removed from the house and Brad has no access to his possessions.

 - Brad spends 10 days locked up before finally deciding to be bailed out. Brad would have been indefinitely locked otherwise before being found guilty of anything and having not even been accused of anything violent.

For in Brad's world there were too many people that wished to see Brad either in a mental institution or in jail and in our society the wrong text message can get you in trouble.

In truth there is a Brad or several Brad's in every community and the way you help Brad is by:
